I am proposing the following personnel to be part of the SOReTWG members, for your perusal. Attached herewith is the list of proposed members.


The Sub-Office Research Technical Working Group Members shall carry the following duties:

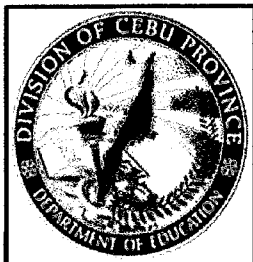
