 - 9. This Office wishes to reiterate and inform all concerned that it has not endorsed, accredited nor authorized any particular supplier to approach the regional and division offices declare himself/herself as the exclusive distributor of the textile materials for the DepEd uniforms. Any uniform supplier who visits DepEd offices and uses the name of the undersigned or of any official in the Central Office (CO) in trying to get a deal for the supply of the DepEd uniforms must be reported to the Office of the Secretary (OSEC), Attention: National Uniform Committee (NUC).
