- 3. All concerned participants are advised to bring medical certificate during the registration period, one afternoon before the said training-workshop. Further they are required to attend all sessions of their selected event on their proper attire, with own gadgets and whistle.

A registration fee of Php 300.00 shall be charged each participant including that of travel expenses incurred, chargeable against Local SEF/Sccchool MOOE funds, while other incidental expenses related to this activity shall be chargeable to Division INSET Funds subject to its usual accounting and auditing rules and regulations.
- 5. District Supervisors/OICs, Elementary and Secondary School Heads are held responsible in assuring the attendance of all concerned for the success of the seminar-workshop in preparation for the Cebu Provincial Sports Festival 2013.
