- 7. Final Planning of all contest administrators, contest coordinators and event consultants will be at Badian NHS on November 15, 2013
- 8. Tarpaulin Designing competition will be done on Day 1 (Nov. 21) at 2:00 to 6:00 p.m. Other skills competition will be simultaneous on Day 2 at 8:00 a.m.
- 9. Registration, travelling and other incidental expenses incurred by the participants shall be chargeable against school MOOE/STEP/PTA/SEF/TVE funds subject to its availability and the usual accounting and auditing rules and regulations.
