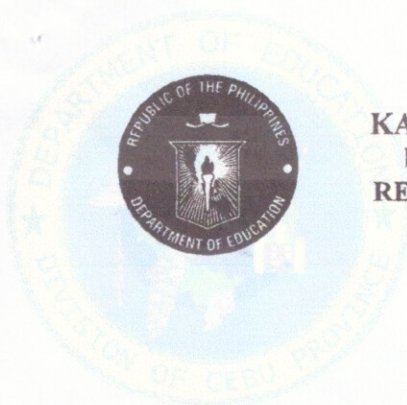

RECOMMENDED ACTIVITIES DURING THE MID-YEAR ASSESSMENT AND INSET

To : Schools Division Superintendents
Officers-in-Charge of Regular and Interim Divisions

1. Considering the calamity that struck Central Visayas and the upcoming Barangay Election on October 28, 2013, this Office reschedules the Mid-Year Assessment and In-Service Training (INSET) from October 28-31 to October 30-31, 2013.

2. As a guide to all concerned, the following are the recommended activities to be done during the conduct of the said undertaking to be led by the School Heads:

- a. Appraisal of the teachers' performance underlining the NCBTS, teacher performance targets and actual pupil/student performance, taking into account the least mastered skills of the learners.
- b. Review of the school activities conducted from June to October 2013, considering the target outputs against accomplishments in the AIP/SIP, standards, means of verification and compelling issues in the plan implementation and school operations.
- c. Alignment of teachers' personal vision to the New DepED Vision.
- d. Clarification of issues concerning the implementation of the K to 12, focusing on Assessment, use of the Rubrics and Grading System.
- f. Innovation, localization/indigenization or digitization of instructional materials to respond to the needs of the K to 12 classrooms.
- g. Integration of Disaster Risk Preparedness, Reduction and Prevention in their daily lessons.
- h. Preparation of school fire/earthquake evacuation and communication plans, and drafting a structural design on improving strength and durability of their respective classroom/building (For those personnel who have background/experience in Building Construction, Architecture, Drafting and Technical Drawing).

3. Division Education Program Supervisors/Coordinators and Public Schools District Supervisors are enjoined to monitor and provide Technical Assistance to all Schools with focus on the abovementioned recommended activities.

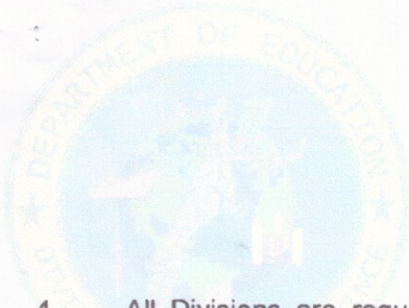


