

3. The DepED Regional Office Election Task Force will ensure that teachers shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties as members of the Board of Election Inspectors (BEIs) as well as principals, supervisors, superintendents and other employees of DepED who will serve during the October 28, 2013 Barangay Elections. This will also serve as DepED's institutional link to volunteer organizations, individuals as well as partner agencies involved in the elections.

4. All Schools Division/City Superintendents (SDSs) are hereby directed to establish their Division Election Task Force. Submit the names of the members on or before October 25, 2013 c/o Miss Ida F. Cabantan, Admin. Division, telephone nos. 231-2160, 255-5239 fax 256-1001. The Division Election Task Force is required to coordinate with the DepED Regional Office Election Task Force and submit a report of all the incidents/complaints regarding the conduct of the election.

5. Expenses for the establishment and operation of the Regional EFT and Division EFT shall be charged to Regional/Division Maintenance and Other Operating Expenses (MOOE), subject to the usual accounting and auditing rules and regulations.
