

RESOLUTION NO. 1201-2013

AUTHOR: HON. THADEO Z. OUANO

REQUESTING ALL LOCAL GOVERNMENT UNITS (LGUs) IN THE PROVINCE OF CEBU TO CALL ON PUBLIC INSTITUTIONS, PRIVATE SECTORS AND THEIR RESPECTIVE CONSTITUENTS TO CONDUCT A SYNCHRONIZED AND CONCERTED WATER CONSERVATION ACTIVITIES ON THE LAST DAY OF THE WATER CONSERVATION MONTH TO MAXIMIZE THE RESULTS OF WATER CONSERVATION INITIATIVES.

WHEREAS, on August 19. 2013, the Sangguniang Panlalawigan approved a resolution requesting all Local Government Units (LGUs) in the Province of Cebu to conduct activities supporting water conservation and to join in the celebration of the "Water Conservation Month" on September:

WHEREAS, during various fora conducted in celebration of the Water Conservation Month, it was emphasized that drinking water in Cebu is in a very critical state and the problem is more pronounced where 80 percent of the supply is pumped out of the ground, straining the aquifer;

WHEREAS, drinking water is diminishing with the increasing demand from a growing population like Cebu because people take water supply for granted instead of treating it like a precious resource which needs our utmost attention and care;

WHEREAS, the real purpose of celebrating Water Conservation Month is not only to educate but a wake-up call for all Cebuanos, for them to be active listeners and propel them into action, to do a real act that would help solve this imminent problem of drinking water that Cebu is currently facing;

WHEREAS, environmental education on water is not just about water or river clean-ups but it is about doing your share in the society. contributing to the solution rather than being a part of the problem, so we must be able to conserve or save any amount of water from our daily undertakings;

WHEREAS, water conservation is just a simple thing to do that even small children can make a difference and when concertedly undertaken by Local Government Units, public institutions, private sector and the community then effects would be colossal:

WHEREAS, there are simple things that can be done to conserve water, for individuals we have practices based on changing water use habits, such as, consider taking shorter showers, use a glass when brushing one's teeth, use water left over from cooking for houseplants and use gray water in washing your cars, in industries, we can apply practices based on modifications in plumbing, fixtures, or water supply operating procedures and reuse and recycling of water;

WHEREAS, with the afore-mentioned practices, a small action could become bigger with greater effects when done by a large number of individuals and with synchronicity, it would create an enormous impact in achieving our goal of conserving water for the benefit of all Cebuanos including future generations;

WHEREAS, the need to coordinate all our efforts in conserving water into a single day to maximize on the impacts of our actions for water conservation which must be done at the last day of water conservation month, not to end the celebration but to signal the new beginning of the objective to restore and replenish the dwindling ground water resources of Cebu;

NOW, THEREFORE, on motion of Majority Floor Leader, Hon. ARLEIGH JAY C. SITOY, duly seconded by Presiding Officer Pro Tempore. Hon. JULIAN B. DAAN for the approval of the resolution authored by Member, Hon. THADEO Z. OUANO, be it

RESOLVED, as it is hereby **RESOLVED** requesting all Local Government Units (LGUs) in the Province of Cebu to call on Public Institutions, Private Sectors and their respective constituents to conduct a synchronized and concerted water conservation activities on the last day of the Water Conservation Month to maximize the results of water conservation initiatives;

RESOLVED FURTHER, that copies of this resolution be furnished to Governor Hilario P. Davide III, all LGUs of the Province of Cebu, DENR, DILG. PNP-PRO 7. DepEd, DA, DOH and BFAR for their information and appropriate action.
