NATIONAL ACCREDITATION COURSE FOR DEPED SCHOOL SPORTS OFFICIATING OFFICIALS AND TRAINING OF COACHES FOR FOUR DEMONSTRATION SPORTS EVENTS IN THE 2014 PALARONG PAMBANSA

The Department of Education (DepEd), through the School Sports Events and Activities Unit (SSEAU) in cooperation with the Philippine Sports Commission (PSC), will conduct the National Accreditation Course for DepEd School Sports Officiating Officials and Training of Coaches for Four Demonstration Sports Events in the 2014 Palarong Pambansa (Futsal, Billiards, Wushu, and Wrestling) in two clusters on the following dates and venues:

- 2. The Accreditation Course aims to:
 - a. accredit qualified school sports officiating officials for school sports competitions;
 - b. update them on the latest trends, rules and regulations on their respective sports disciplines; and
 - c. upgade and improve their competencies in managing and officiating in school sports competitions.

- 3. The regular sports disciplines include: Archery, Arnis, Athletics, Badminton, Baseball, Basketball, Boxing, Chess, Football, Gymnastics, Sepak Takraw, Softball, Swimming, Taekwondo, Table Tennis, Tennis and Volleyball. Futsal, Billiards, Wushu, and Wrestling shall remain as demonstration sports events in the 2014 Palarong Pambansa; hence, the need for this course and training.
- 4. The Luzon Cluster will be divided into two batches to accommodate the participants in the billeting venues. For Batch 1, the sports events are Archery, Arnis, Badminton, Boxing, Gymnastics, Lawn Tennis, Softball, Sepak Takraw, and Volleyball; while Batch 2 is composed of Athletics, Basketball, Baseball, Chess, Football, Table Tennis, Taekwondo, and Swimming. Likewise, the training of the four demonstration sports shall be held on January 17-19, 2014.
- 5. There shall be five participants from each region per event, including the demonstration sports. However, for Athletics, Swimming, and Lawn Tennis, ten participants are alloted for each sports event per region. All entries shall be endorsed by the Regional Physical Education and School Sports (PESS) Chief. Those who are not duly endorsed by the Regional PESS Chief shall not be accommodated.
- 6. Participants must meet the following requirements:
 - a. must be physically fit;
 - b. must not be more than 50 years old as of January 2014;
 - c. must possess knowledge and skills in their respective fields of sports discipline;
 - d. must have officiated in the Division/Regional Meets for the past three years, as certified by the Regional PESS Chief;
 - e. must be endorsed by the Regional PESS Chief; and
 - f. must bring their complete sports attire and racket equipment (for racket events) for practicum.
- 7. A registration fee of Three Thousand Pesos (P 3,000.00) shall be charged to each participant, including the management staff and resource persons to defray expenses for food, accommodation, supplies and kit, rental of venues/transportation, honoraria, and other incidental expenses. Regional participants' expenses and registration fees shall be charged to local funds, while those of the management staff and resource persons shall be charged to Office of the Secretary (OSEC) Funds, subject to the usual accounting and auditing rules and regulations.
