- 1. Pursuant to Presidential Proclamation No. 683 dated January 28, 1991, entitled Declaring the Month of February of Every Year as National Arts Month, the National Commission for Culture and the Arts (NCCA) will lead the 23rd National Arts Month Celebration dubbed as Philippine Arts Festival 2014 with the theme Art on the Edge in February.
- 2. The objective of the Celebration is to promote Philippine culture and the arts, highlighting the empowerment of the Filipino's creativity and imagination. Specifically, it aims to:
 - a. foster camaraderie among the schools, universities, artists, art organizations, brands, and companies;
 - b. promote and popularize the outstanding creations of Filipino artists in the seven arts for all sectors both local and international;
 - c. promote the integration of arts in community life;
 - d. underscore the significant role of art and artist, and other stakeholders in uplifting the nation's spirit; and
 - e. utilize art as a catalyst for Values Education or Edukasyon sa Pagpapakatao.
- 3. This year's Celebration will be a call to hope, a challenge to act, an invitation to commit, a celebration of creativity, and an affirmation of Filipino's strength that can be a catalyst for social transformation.
- 4. The suggested activities to be undertaken by the agency or institution in accordance with its own capabilities during the Celebration are as follows:
 - a. music rendition;
 - b. dance or theater performances;
 - c. film or visual arts exhibits;
 - d. visit to museums or cultural sites;
 - e. display of agency's own streamers; and
 - f. posting of posters and other information materials within or outside their offices.
