ADDENDUM/ CORRIGENDUM TO RM NO. 068, S. 2014, ENTITLED "CONDUCT OF THE FIRST REGIONAL LEVEL SPFL FESTIVAL OF TALENTS"

- 1. In consonance with the conduct of the 1st Regional Level SPFL Festival of Talents on February 28, 2014 at the Executive Dining Hall, DepEd Ecotech Center, the following items have to be considered as addendum/corrigendum to the previous Memorandum No. 068, s. 2014 entitled "Conduct of the First Regional Level SPFL Festival of Talents", which focus on the following paragraphs:
 - a) Paragraph 5 On the inclusion of the 750-00 Registration Fee. A registration fee of Seven Hundred fifty Pesos (Php750.00) that includes rental for the venue, one (1) breakfast, two (2) snacks, one (1) lunch, medals/ trophies/ cash prizes for the winners, and honorarium for the judges and members of the Technical Working Group (TWG), as well as the dormitory accommodation (non-inclusive of the registration fee), transportation fare & other incidental expenses incurred during this activity shall be charged to Local funds/ Division/School MOOE/ SEF & other available funds, subject to the usual accounting and auditing rules and regulations.
 - b) On the Contest Categories. There will be three (3) contest categories to be competed:
 - Quiz Whiz
 - Extemporaneous Speech
 - Characters on Parade/ Cosplay The cosplayer shall say something about the character and the country. The criteria are as follows:

Authenticity - 30%
Oral Presentation - 30%
Stage presence - 20%
Audience impact - 20%
100%

c) On the Awards. All winning students from the three (3) contest categories shall receive cash prizes (to be claimed later from the Regional Office Cashier Division), Certificates of Recognition, and medals. The winning coaches shall also receive Certificates of Recognition.
