#### Training on the second-level coaching for special program IN SPORTS (SPS) IMPLEMENTERS

Regional Directors To: Schools Division Superintendents Heads, Public and Private Secondary Schools All Others Concerned

- As a sequel to the training on the first-level coaching conducted by the Department of Education (DepEd) through the Bureau of Secondary Education (BSE), the Training on the Second-Level Coaching for Special Program in Sports (SPS) Implementers will be conducted from March 31 to April 4, 2014 at the Teachers Camp, Baguio City.
- The training aims to continue to enhance the knowledge and skills of participants on the new trends and strategies in coaching sports, which can be applied in the course of the SPS implementation.
- 3. The participants include:
  - a. one regional sports supervisor;
  - b. one division sports supervisor;
  - e. school sports coordinators;
  - d. school heads; and
  - e. teachers.
- Those teachers who were not able to attend the training on the first-level coaching for some reasons, but have been attending the previous SPS trainings, may also attend this training.
- All teacher-participants are required to bring a certification that they are coaching a team in their schools signed by the school heads.
- A registration fee of Five Thousand Pesos (P 5,000.00) shall be charged to each participant to cover board and lodging, transportation of participants to and from the practicum venues, supplies and materials, and other incidental expenses relative to the conduct of the training-seminar. The registration fee and traveling expenses of participants shall be charged to Maintenance and Other Operating Expenses (MOOE)/Special Education Funds (SEF)/local funds, while board and lodging and traveling expenses of resource persons and training staff shall be charged to the BSE Policy Formulation Funds as provided for in the 2014 DepEd General Appropriations, subject to the usual accounting and auditing rules and regulations.
- Registration will start on March 30, 2014 at 3:00 p.m. at the Romulo Hall, Jr. Mess, Teachers Camp, Baguio City. The first meal to be served will be dinner on March 30 and the last meal will be lunch on April 4, 2014.
