Registration fee of **Three Hundred Pesos (PhP 300.00)**, inclusive of honoraria of resource speakers, training materials and certificates; and expenses for the venue, meals and snacks shall be chargeable against Division INSET Funds, while travelling expenses shall be chargeable against local school MOOE/SEF/PTA Funds, subject to availability and the usual accounting and auditing rules and procedures.
