- The Department of Education (DepEd), through the Procurement Service-Bids and Awards Committee (PS-BAC) Secretariat, in coordination with the Communications Unit under the Office of the Chief of Staff, and with technical assistance provided by the Philippine Government Electronic Procurement Systems' (PhilGEPS), has completed the Integration of the PhilGEPS Notices Publication Interface (NPI) in the DepEd Website, wherein invitations to bid and notices of award posted are simultaneously displayed.
- The NPI streamlines the posting requirement by automatically uploading in the DepEd website the same information posted in the PhilGEPS. Thus, procuring entities at all levels in the DepEd will no longer input the same data in their own respective websites. The system eliminates the need for repetitive procedures and enables the regions, divisions and schools, without a website to fully comply with the posting requirements mandated under Republic Act (RA) No. 9184 entitled Government Procurement Reform Act and its Implementing Rules and Regulations (IRR).
- The integration shall provide suppliers and prospective bidders with a uniform set of information resulting to a more transparent and competitive procurement at all levels in the DepEd.
- Relative thereto, DepEd Order No. 42, s. 2013, on PhilGEPS posting requirements of all projects bid out and awarded is hereby reiterated.
