MALIKHAING GURO INTERNATIONAL CULTURE-BASED EDUCATION AND ARTS CONFERENCE 2014

To: Regional Directors
Schools Division Superintendents
Heads, Public and Private Secondary Schools

- 1. In support of the Memorandum of Agreement (MOA) between the National Commission for Culture and the Arts (NCCA) and the Department of Education (DepEd), which was signed on February 9, 2013, the NCCA and the Arts Research and Training Institute in Southern Tagalog, (ARTIST), Inc., in partnership with the Linang Arts and Culture Network, Inc. and the University of the Philippines Los Baños (UPLB), announce the conduct of the Malikhaing Guro International Culture-Based Education and Arts Conference 2014 to be held from July 23 to 26, 2014 at the UPLB, Laguna.
- 2. The Conference aims to gather educators, pedagogues, art educators, cultural workers, and arts practitioners who are engaged in culture-based education across nations. Furthermore, the event hopes to highlight the different experiences in culture-based education and the art of different countries in Asia-Pacific and Europe, including those from the member countries of the Association of Southeast Asian Nations (ASEAN).
- 3. The topics included in the Conference are the following:
 - a. Integration and Teaching of Foreign Culture in Basic Education;
 - b. Tapping Local Culture in Education;
 - c. Teaching Filipino Culture and Languages in Foreign Countries;
 - d. Culture-related Policies in Advancing ASEAN Integration;
 - e. Culture-based Arts in Education;
 - f. Culture-based Education in Arts;
 - g. Collaboration and Partnership in the Arts;
 - h. Collaboration in Academe and Community through Arts;
 - i. Developing Lesson Plan Exemplar; and
 - j. Developing National Competency for the School Program for the Arts.
- 4. The topics included in the workshop demonstrations are the following:
 - a. Storytelling;
 - b. Traditional Craft Making;
 - c. Indigenous Music and Community Chants;
 - d. Role-playing for Cultural Heritage Dissemination;
 - e. Indigenized Performances in Classroom-Setting;
 - f. Utilizing the Folk Media as Instructional Materials; and
 - g. Culture-based Lesson Plan Exemplar.

- 5. The target participants are DepEd teachers of any grade level nationwide and representatives from different countries in Asia-Pacific and Europe and those from ASEAN member countries.
- 6. The NCCA shall provide the scholarship programs with free registration, conference kits, workshop materials and viewing of poster exhibits and video-documentaries of local heritage for the duration of two days for 30 participants who would be accepted to present papers, lesson plan exemplars, posters or two-to-three minute video documentaries of local heritage, or to conduct workshop demonstrations. Selection will be on a competitive basis.
- 7. The format and requirements for the scholarship programs are the following:

Lesson Plan Exemplar	a. The presenter should submit the lesson plan

	conform to DepEd's standard format.

	maximum of 15 minutes.		
	d. The actual conduct of the presentation		
	should be in English.		
Video Documentary	a. The presenter should submit an abstract not		
	exceeding 300 words.		
	b. The video documentary must not exceed a running time of three minutes.		
	c. It may use local language but the subtitle must be in English.		
Poster Paper			
Presentation	the poster not exceeding 300 words.

8. The transportation, accommodation and other expenses not covered by the scholarship shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.

- 9. Applications must be sent to <u>malikhaingguro@gmail.com</u> together with the following: (a) an abstract of the paper or workshop demonstration (maximum of 300 words); (b) duly completed registration form (copy enclosed); and (c) professional curriculum vitae (CV). The deadline for submission of application is on or before **June 30, 2014**.
- 10. Beyond the first 30 enrolees, each additional participant shall be charged a registration fee of One Thousand Five Hundred Pesos (P 1,500.00) to cover expenses for registration, conference and workshop materials. They shall also be responsible for all other relative expenses, which may be charged to local funds, subject to the usual accounting and auditing rules and regulations.
- 11. All teacher-applicants, either presenter or participant, must submit an endorsement letter from their schools division superintendent, district supervisor, school head or principal.
