DEPED INTER - DIVISION BASKETBALL TOURNAMENT

GROUND RULES

- 1. To be eligible to participate in this tournament, a player must be a DepEd employee in a certain public school(local o national) in their respective Division, City or Municipality.
- 2. Participating teams must have twelve (12) to fifteen (15) players, below 12 players during the game scheduled the team will be penalized, the opposing team will be given plus 2 points per player at the start of the third quarter(in case a player will arrive in the third quarter, he is still allowed to play in the fourth(4) quarter or depending upon the decision of their coach.
- 3. All participating teams must submit their official line up during the opening ceremony on (July 12, 2014) (Saturday) with a photocopy of their player/s I.D. (after the submission of official line up a team cannot add another player in their rooster).
- 4. During the Opening Ceremony all teams must pay 100% of the total entrance fee in the amount of four thousand, five hundred pesos only (P 4,500.00), failure to pay such obligations, will not be included in the tournament (for the payment of the referees and table officials).
- 5. The team shall be managed by a team manager (District Supervisor, Administrative Officer, Division Supervisor or Schools Division Superintendent).
- 6. All players must wear their official uniform during the opening program and in every game scheduled (only player with official uniform is allowed to play).
- 7. Player/players under the influence of liquor are not allowed to play. The technical committee shall decide on this particular issue.
- 8. Only players, coach, assistant coach and team manager are allowed to sit at the team bench.
- Games shall be played as scheduled. A mandatory 30-minute grace period is allowed, beyond this
 time, the committee will declare forfeited in favor of the team present. Rules of succession shall strictly
 be observed, you should be 1 hour before your game scheduled).
- 10. Barangayan format will be used, 5 players shall play in each quarter, in the 1st to 3rd quarter no substitution is allowed (in case a player is injured replacement is allowed but the opposing coach will choose a player to replace the injured player)
- 11. Coach and assistant coach must be a player or DepEd Employee in their respective division or municipality. They must be in proper attire.
- 12. A player who committed unsportsmanlike foul or heavy foul will be given a technical foul (two free throws plus ball position to the opposing team); two technical fouls will be automatically thrown out of the game plus one game suspension on the next game.
- 13. A single round robin format is adapted in this tournament, after the elimination round the top 4 teams will advance to the semi-final round. # 1 vs. # 4, and #2 vs. # 3 for a knock out game. The winner will advance to the championship round and the losing teams will play for the 3rd place in a single knock out game. (at the end of the elimination round, a team with no defeat shall have a twice to beat advantage).
- 14. In case of double tie" Win Over the Other" system shall be used to break tie. In case of a triple tie or multiple ties, the average or quotient system shall be used to break the tie.
- 15. Strictly, only coach will be allowed to discuss/ question relative to the ongoing game.
- 16. The game will be played by quarter, with ten(10) minutes per quarter, their will be one(1) time out 1st to 3rd quarter and two(2) time outs in the 4th quarter(in case a time out in the 3rd quarter were not utilized it can be used in the 4th quarter).
- 17. Intentional foul, deliberate foul that resulted to a technical foul, a player committed such infraction will rest for 3 minutes with out substitution.
- 18. The game will be played every Saturday from 3:00 PM to 8:00PM with the possible venue (Lapu-Lapu City, Mandaue City and Cebu City).
- 19. Lastly, FIBA General Rules and Guidelines is still applicable in this tournament which is not mention in the ground rules.
