In line with the advocacy of the Bangko Sentral ng Pilipinas (BSP) on financial inclusion, financial education, and financial consumer protection, the Financial Consumer Affairs Froup (FCAG) will conduct the Money Matters for Kids (MMK) Exhibit in Cebu City on 5. to 14 November 2014 at the BSP Cebu Regional Office which is located at Corner Osmena Blvd & P. del Rosario Sts., Cebu City

The MMK is an interactive exhibit on financial literacy designed to provide young children aged 12 and below, with a fun way of learning the concepts of money, saving, spending, and sharing, as well as the importance of saving for the future.

This exhibit is one of BSP's many financial education initiatives that aim to empower financial consumers to make informed financial decisions and improve their financial well-being. This is the 5th time that the BSP will be holding the Exhibit. The first, second and third were in Metropolitan Museum of Manila, Gateway Mall, Cubao and U.P. Los Banos, respectively. To date, the MMK Exhibit reached a total of 15,660 children and adult exhibit viewers.

Right now the fourth MMK Exhibit is still ongoing at the MET Museum of Manila and will run until 18 August 2014.

In connection with this, may we visit your office and set a meeting with you and your representatives sometime between 11 to 13 of August 2014 at whatever time of your convenience to discuss the details of the MMK Project. A short PowerPoint presentation of the MMK exhibit will be made during the meeting.

The meeting will focus mainly on the following requests:

- a) Disseminate the information regarding the forthcoming MMK Exhibit;
- b) Identify the schools and number of pupils who are interested to view the Exhibit and engage in financial learning activities; and
- c) Invite the principals of various participating schools for the Opening of the Exhibit on 5 November at 9:30 a.m.
