For TIC and P-I positions, the qualification standards stipulated in DepEd Order No. 42, s. 2007 (The Revised Guidelines in the Selection, Promotion and Designation of School Heads) shall be observed.
- 3. Applicants for School Head Positions shall be ranked according to criteria specified in DO No. 42, s. 2007.
- 4. Applicants for the positions of Public Schools District Supervisor (PSDS) and Education Program Supervisor (EPS) shall follow the qualification standards expressed in CSC 2007 QS and CSC Resolution No. 1000275, dated November 2, 2010, respectively. For purpose of determining the qualified applicants for PSDS position, the term "related experience" shall be understood as "the experience of the applicant gained as District OIC or District Caretaker", as per PSB Resolution No. 28 s. 2012.
- 5. Applicants to PSDS and EPS positions shall be rated, according to the criteria laid down in DepEd Order No. 66, s. 2007 (Revised Guidelines on the Appointment and Promotion of Other Teaching, Teaching Related and Non-Teaching Positions).
- 6. Interested applicants are directed to bring the original and certified photo copies of following pertinent documents during the interview:
 - a. PASSA for incumbent School Heads or RPAST for Teachers in the last three rating periods. (For teachers: 1st and 2nd sem SY 2013-2014 and 1st sem SY 2014-2015; For incumbent School Head: 1st and 2nd sem CY2013 and 1st sem CY 2014)
 - b. Latest Appointment
 - c. Updated Service Records
 - d. Certificate of outstanding accomplishment
 - e. NQESH Result (for applicants to P-I position only)
 - f. Transcript of Records
