(NUCESO) will celebrate the 41<sup>st</sup> Anniversary of the CES culminating with the 13<sup>th</sup> Annual CES Conference on 12-14 November 2014 at the Waterfront Cebu City Hotel and Casino, Salinas Drive, Lahug, Cebu City.

To situate CES leaders in the age of digital democracy, this year's conference theme is "Leadership Excellence in the Digital Era: From Nation - Building to Global Governance."
