- Pursuant to Presidential Proclamation No. 829 dated November 8, 1991 entitled Declaring the Period from November 10-16 of Every Year as the Deaf Awareness Week, the Department of Education (DepEd), through the Bureau of Elementary Education (BEE)-Special Education (SPED) Division, in coordination with the Philippine Institute for the Deaf and Philippine School for the Deaf, will lead the 2014 National Observance of Deaf Awareness Week (DAW). The National Council on Disability Affairs (NCDA) will host this year's celebration.
- With the theme Healthy Ear: Advocacy and Responsibility, the observance aims 2. to enhance significant public awareness on the prevention, early detection, intervention, rehabilitation and education of the people with hearing impairment together with able peers.
