## TRAINING ON THE ADMINISTRATION OF THE PHYSICAL FITNESS TESTS (PFT)

To: **Bureau Directors** Regional Secretary, ARMM Regional Directors Schools Division Superintendents Heads, Public Secondary Schools

- The Department of Education (DepEd), through the Bureau of Secondary Education (BSE), shall conduct the Training on the Administration of the Physical Fitness Tests (PFT) from November 18-20, 2014 at Teachers Camp, Baguio City.
- 2. The Training aims to provide a tool to:
  - a. assess the students' level of fitness;
  - b. identify strengths and areas for development/improvement;
  - c. determine bases for the selection of physical activities for enhancement;
  - d. gather and analyze data for norms and standards setting;
  - e. motivate and guide students in choosing the sports activities they would like to participate in; and
  - assist the teachers in the administration of the PFT.
- Participants in the training are the regional and division Physical Education and Schools Sports (PESS) Supervisors, sports coordinators, and teachers of schools implementing Special Program in Sports (SPS).
- A registration fee of Three Thousand Five Hundred Pesos (P 3,500.00) shall be charged to each participant to cover board and lodging, training kit, miscellaneous and other incidental expenses relative to the training. Registration fee and travel expenses of participants shall be charged to the Maintenance and Other Operating Expenses (MOOE)/Special Education Fund (SEF)/local funds, while board and lodging and travel expenses of resource persons and training staff shall be charged to BSE Funds, subject to the usual accounting and auditing rules and regulations.
- The registration will start at 1:30 p.m. on November 17, 2014 at the venue. 5. The first meal to be served will be dinner on November 17 and the last meal will be p.m. snacks on November 20, 2014. The form for the Confirmation of Registration of Participants and the Schedule of Activities are provided in the enclosures.
