#### **CORRIGENDUM TO DIVISION MEMORANDA NOS. 53 AND 137, S. 2015**

(Re: Announcing the Schedule of Recruitment and Selection of Applicants for Teacher-1 Position for SY 2015-2016)

- 1. The field is hereby informed of the following changes to Division Memoranda Nos. 53 and 137, s. 2015, to wit:
  - A. All applicants are directed to register to DepEd's online system at application.deped.gov.ph. Each registrant will be given an Application Number. This number shall be indicated in the application letter of the applicant. Those who have submitted their application letter prior to the issuance of this Order, are still required to register and to submit their application number to the Division Office. New applicants are given until April 8, 2015 to submit their application letters in schools nearest to their residence.
  - B.1 The application letter shall be supported by the following documents:
    - I. CSC Form 212 in two copies with the latest 2 x 2 ID picture
    - II. Certified photo copy of PRC license or a PRC certification showing the teacher's name LET rating and other information recorded in the PRC Office
    - III. Certified photo copy of ratings obtained in the LET/PBET
    - IV. Certified photo copy of transcript of records
    - V. Copies of service records, performance rating, and school clearance for those with teaching experience. If unavailable, the applicant must submit a justification citing the reason/s for unavailability
    - VI. Certificates of specialized trainings, if any
    - VII. Certified copy of Voter's ID and/ or any proof of residency as deemed acceptable by the School Screening Committee
    - VIII. NBI Clearance
    - IX. Omnibus certification of authenticity and veracity of all documents submitted, signed by the applicants

- B.2 Applicants may submit additional documents, in line with the changes of the S.Y. 2015-2016 hiring guidelines.
