Pursuant to DepEd Memorandum No. DM 12, s. 2015 entitled 2015 National Festival of Talents (NFOT), the scheduled Festival had been reset from April 7-10, 2015 to April 8-11, 2015 due to the threat posed by the super typhoon Maysak (Chedeng) which hit the country on the second week of April.

Expenses incurred by the official NFOT delegates who rebooked their plane tickets to and from the venue and were charged with penalties and/or fare difference by the ticket agent/airline shall be charged to the school Maintaining and Other Operating Expenses (MOOE/local and regional funds/Special Education Funds (SEF) or other source of funds, subject to the usual accounting and auditing rules and regulations.
