



GENERAL INFORMATION

Move This World (MTW) is a global nonprofit that uses creative movement as a vehicle to transform conflict, violence and bullying in communities. MTW focuses specifically on empowering individuals with the necessary skills to identify emotions within themselves, be empathetic in their interactions with others, and act as change agents in their communities. MTW has worked with over 15,000 individuals across 22 cities on four continents to build and connect more peaceful communities.

Our hallmark program is an innovative, evidence-based curriculum that engages students Pre-K-12, families, educators, administrators, and company leaders in movement-based activities that promote empathy, mediation skills, diversity appreciation, anger management, and conflict transformation. In this way, MTW fosters cumulative skill building that grows with the individual and produces measurable impact. Our vision is to change the way we teach and learn, with movement and empathy at the core.

Course Description. This four-day short course will introduce innovative and evidence-based approaches of using curricular exercise, creative expression, and mindfulness activities to enhance empathetic behavior, create safe spaces, and attain mental health through social and emotional intelligences. It is especially designed to equip School Administrators, Child Protection Officers, and Child's Rights Advocates the theory and experience of addressing violence that can jeopardize the welfare of children.

Withdrawal Policy

Move This World will refund 100% of the tuition fee if cancellation of application is made on or before October 22, 2015; a 75% refund, if cancellation is made on or before November 1, 2015; and a 50% refund if participants withdraw a week before the class schedule.

Travel Costs

Participants or their sponsoring organization will have to cover all travel expenses (international and domestic airfares, local transportation, visa fee, etc.) and make the necessary travel arrangements.

Visa Assistance
