Project Title:

Linking the Interests of Families and Teachers (LIFT)

II. Overview:

Linking the Interests of Families and Teachers (LIFT) is a school- and community - based intervention program designed to improve positive social behavior, family interaction, and school/home coordination, reduce delinquent behavior later in life.

It is an intervention program designed to reduce substance abuse and behavioral problems during adolescence.

#### III. Background

On May 2015, the CPADAC and the DEPEd already held training activity involving the various presidents of the student councils in the province.

During this forum, it was emphasized to the participants the need for cohesion and action among the youth and students and their peer counseling on their fellow youth and students.

In recent years, there has been no programs yet involving the PTAS. For this reason, so far, there has been no programs implemented that sought to renew and strengthen the linkages between the actions of the student and the parents and the schools and the communities with regards to drug abuse.

#### IV. Objectives

The LIFT seeks to attain the following:

- Promote and scale up the drug awareness among the Parent Teachers Associations and the schools;
- 2. Establish An AdHoc Group on the Network of PTA's and Schools on Drug Awareness;

- 3. Draw a Minimum Short Term Plan for PTA's and Schools on Drug Awareness;
- 4. Identification of Resource Persons from the Ranks of the PTA and Schools for Sustainable Drug Awareness Programs;

#### Principles/Approaches/Components: ٧.

The LIFT Program is based on the premise that the behavior of a person, and his drift or propensity towards a life of delinquency and violence, is developed at an early stage in life. Inversely, a positive outcome and a life that firmly rejects or repels unwholesome elements also start early in life.

Thus, the development of children and the youth and their upbringing, and in this regard, the family, and the teachers, in the various communities, are very relevant factors for the tendencies towards success or failures of children. The family in particular, the schools are the very basic social institutions where the children and the youth are exposed and reared to conditions that impact on the future of persons.

LIFT focuses on oppositional and socially inept behavior in children and on discipline and monitoring strategies used by parents. It consists of five main components:

- 1) Classroom- based social skills training for children, including problem-solving, skills review, and rewards;
- (2) The Good Behavior Game, focusing on group interaction and positive and negative behaviors of children at recess or in a playground setting;
- (3) Parent management training, including lecture, discussion, role-play of issues, and review and presentation of home practice exercises
- (4) Improving parenting skills (e.g., monitoring, expressing affection, setting limits),
- (5) Building life skills in youth (e.g., resisting peer pressure, managing emotions, setting goals), and strengthening family bonds.

#### II. Project Title:

PROJECT S.E.E.K – School-based Education Enhances Knowledge (SEEK) for Drug Abuse Prevention

#### II. Overview

Project SEEK is a program that attempts to provide a conceptual basis upon which teachers and school administrators in developing better school- based drug prevention programs

The Program provides skills – training in developing and implementing drug education programs. It also outlines how these programs are supported by a whole-school approach for the purpose of promoting health and wellbeing vis-à-vis students and the community at large.

# III. Objectives

The program aims to:

- 1) To improve the effectiveness of the curriculum- based approach to drug education
- 2) To encourage best practice principles in the design, delivery and evaluation of school- based drug education
- 3) To provide guidelines on how to plan and evaluate drug education over time to ensure it is consistent with best practice

#### IV. Principles/Approaches/Components

Project SEEK is a program that adopts and implements best practices as major instrument in the design, delivery and evaluation of drug education programs.

Given that young people are exposed to situations where legal and illegal drugs are used, it is essential they have the opportunity to experience effective bests practice in drug education as a major tool for enhancement of their social skills, improvement of their knowledge.

With these experiences, it is hoped that the youth is able to better and positive attitudes in life, their career and studies and that they would reject away from drugs and drug use.

The approach to drug education outlined in this program aims to prevent and to reduce drug-related harm in schools.

Consistent hereof, it recommends an inclusive approach where all students, whether they use drugs or not, are able to access, enhance and gain knowledge and skills so they can make informed choices about drug use.
