

On behalf of Dalaguete's Mayor Ronald Alan G. Cesante I would like to offer the services of Dalaguete's Technical Education and Skills Development Authority (TESDA) registered and accredited STAR Center to offer Cebu's secondary school teachers, especially those teachers in Southern Cebu the opportunity to earn the coveted TESDA NC II certification required for the K-12 curriculum during non-school year time.

The training, as explained in the attached proposal would commence on the first Monday after the end of the 2015-2016 school year and conclude with TESDA administered assessments during the last week of May 2016. There would be five TESDA NC II level courses offered: (1) Automotive Servicing, (2) Cookery, (3) Dressmaking, (4) Electrical installation and Maintenance (EIM) and (5) Shielded Metal Arc Welding (SMAW).

Tuition and other related fees are the responsibility of each student

Progress reports will be provided to school heads every two weeks on all participating teachers from their school with copies sent to District supervisors

March 25 first day of class

- STAR Center and TESDA orientation
- STAR Center Trade and Course Orientation

May 15 preparations for assessment begins

May 25 TESDA administered Assessments begin

Classes run Monday through Friday of each week

Classes begin at 8:00am each day and conclude at 5:00pm

One hour for lunch

One 15 minute break before lunch and one 15 minute break after lunch – given at the instructor's discretion

Dalaguete, TESDA and DepEd K-12 Tripartite Agreement

PROPOSAL

Mayor Cesante, understanding the challenges secondary school teachers face in acquiringTESDA NC II certification has directed Dalaguete's Skills Training and Resource (STAR) Center to rearrange its training schedule to meet the needs of DepEd's K-12 system and secondary school teachers. The new schedule will provide a single term for DepEd secondary school teachers that would commence on the first Monday after the 2015-2016 school year ends and would conclude the last week of May. There would be five TESDA NC II level courses offered: (1) Automotive Servicing, (2) Cookery, (3) Dressmaking, (4) Electrical Installation and Maintenance and (5) Shielded Metal Arc Welding. House Keeping and Bread and Pastries courses could be considered should they be deemed appropriate.

DISCUSSION

- Secondary Schools are required by Philippine law to provide technical-vocational training as part of the K-12 curriculum. Many secondary school teachers must possess the TESDA NC II certification as part of the K-12 requirement;
- Informal discussions with DepEd and TESDA officials revealed many secondary school teachers in the Philippines have taken the TESDA NC II assessment without taking the requisite course and subsequently failed the TESDA assessment. This proposal offers a viable solution to the current quagmire and does so at minimal cost to teachers;
- STAR Center fees range from 40% to 75% less than private institutions offering the same courses;
- Teachers will be responsible for all fees and tuition costs in accordance with exhibit 1 of this proposal;
- All fees shall be paid in accordance with exhibit 2 of this proposal;
- Exhibit 3 details the STAR Center Batch 30 proposed Calendar of Events;
- The revised STAR Center schedule is designed to meet the needs of teachers who cannot complete the training during the regular DepEd school year;
- Only secondary school teachers and school administrators endorsed by their current school head are eligible to enroll unless STAR Center enrollment does not achieve maximum enrollment in which case enrollment will be opened to the public;
- Prerequisite for conducting a course of training is minimum enrollment of 20;
- Training will be conducted at the STAR Center campus by STAR Center trainers;
- The STAR Center has a proven track record of training its students in a manner consistent with TESDA requirements by maintaining curriculum aligned with TESDA and DepEd's tech-voc education requirements;
