URGING THE DEPARTMENT OF EDUCATION, DIVISION OF CEBU PROVINCE TO INCLUDE LOCAL CULTURAL AND HISTORICAL FACTS OF THE PROVINCE OF CEBU IN CULTURE AND HISTORY RELATED SUBJECTS WITHIN ELEMENTARY, JUNIOR HIGH AND SENIOR HIGH SCHOOL LEVELS.

WHEREAS, Republic Act No. 4846, otherwise known as, "An Act to Repeal Act Thirty-Eight Hundred Seventy Four and to Provide for the Protection and Preservation of Philippine Cultural Properties (as amended by P.D. 374) only aims to protect and preserve the historical properties and does not involve the perpetuation of the values that these properties possesses";

WHEREAS, the Province of Cebu is dominantly rich of historical and cultural facts from pre-colonial Spanish to the advent and fall of the Japanese regime;

WHEREAS, including these historical and cultural facts in culture and history subjects is the grandest scheme to inculcate nationalism and patriotism in the youth;

WHEREAS, this august Body believes in the importance of preserving and protecting our historical properties. However, with the exemption of historical places, most of them are found in the museums which are not readily available to the distant public. Thus, this does not arrest the understanding of the new generation of the values or priceless stories behind these

historical properties. If the mind of the youth of today, particularly the Cebuano youth, will not be planted with the seed of the said historical value, preserved and symbolized through these historical figures, then a point might come that Cebuanos will become alienated with these historical properties;
