AUTHOR: HON. MIGUEL ANTONIO A. MAGPALE

URGING THE DEPARTMENT OF EDUCATION VII (DepEd VII) TO PROVIDE PERIODIC STRESS MANAGEMENT PROGRAMS AND DEVELOP STRESS COPING MECHANISMS FOR ALL PUBLIC SCHOOL TEACHERS IN THE PROVINCE OF CEBU.

WHEREAS, Chapter 2, Section 17 of the 1987 Philippine Constitution provided that, "The State shall give priority to education, science and technology, arts, culture, and sports, to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development:

WHEREAS, according to numerous studies, stress is very common to the teaching profession. Study shows that the effects of stress and burnout are damaging for teachers, students and the education field in general. Further, work related stress may lead to varying health problems affecting physiological and psychological health, as well as the worker's cognition and behaviors;

WHEREAS, lack of classrooms and other necessary learning equipment and uneven ratio between students and teacher are some realities in most public schools that challenge the public school teachers in delivering quality education, which in turn causes stress;

WHEREAS, this august Body believes in the huge impact of providing stress coping mechanisms for all public school teachers in the Province of Cebu for it will not only greatly help them perform well inside their respective classrooms, but also in dealing with different aspects of their personal lives;

NOW THEREFORE, on motion of Majority Floor Leader, Hon. JUDE THADDEUS DURANO SYBICO, duly seconded by Presiding Officer Pro Tempore, Hon. JULIAN B. DAAN, for the approval of the resolution authored by Member, Hon. MIGUEL ANTONIO A. MAGPALE, be it

RESOLVED as it is hereby **RESOLVED**, to urge the Department of Education VII (DepEd VII) to provide periodic stress management programs and develop stress coping mechanisms for all Public School Teachers in the Province of Cebu;
