- Parents' Permit shall be required from the Municipal Federation Supreme Student Government (SSG) President which will be also submitted as attachment to the Pre- Registration Form.
- Travelling and other incidental expenses incurred relative to the participation of 7. the said election of the participants shall be chargeable to the school MOOE or Supreme Student Government (SSG) Fund, subject to its availability and the usual accounting rules and procedures.
