JOINT ELEMENTARY AND SECONDARY ENGLISH FEST 2016

1. To spread the season's cheers and in keeping with the National Reading Month celebration, this Office announces the conduct of the **Joint Elementary and Secondary English Fest 2016** with the theme, "Beating the Odds this Yuletide 2016". The conduct of the cluster activity shall follow the schedule below, while the date and venue of the **Division Joint Elementary and Secondary English Fest** shall be announced later.

Cluster	Date	Host
South (SE and SW)	November 29, 2016	Sibonga District
North (NE and NW)	December 1, 2016	Medellin District

- 2. Participants to this Joint English Festival are the pupils from Grades 3-6 and students from Grades 7-11 in both public and private elementary and secondary schools. Elementary pupils shall compete in Read-A-Thon, Story Retelling, Spelling Bee, Essay Writing and Extemporaneous Speaking. At the same time, Grade 7 students shall compete in Read-A-Thon, Grade 8 in Cosplay, Grade 9 in Spelling Bee, Grade 10 in Essay Writing, while those in Grade 11 shall join the Extemporaneous Speaking contest.
- 3. They are all required to observe strictly the contest mechanics and guidelines set for the different categories. Read-A-Thon for Grade 7 students shall observe the same procedure as that of Grade 6 pupils. Coaches, pupils, students and members of Contest Committees are enjoined to come to the venue on time so issues can be readily resolved and competitions can start immediately.

- 4. The Top Six Winners in the individual contest categories and Read-A-Thon shall qualify for the Division Level.
- 5. A registration fee of **Five Hundred Pesos** (Php 500.00) shall be charged each delegation, either district or municipal, to defray the cost of stage decoration, sound system, contest materials, judges' honoraria, meals, snacks and medals.
- 6. Registration, travel, meals and other expenses incurred by participants shall be charged to **SEF/School MOOE/PTA Funds**, subject to their availability and the usual accounting, as well as auditing rules and procedures.
- 7. This Memorandum shall serve as the Participants' Authority to Travel.
- 8. Immediate dissemination of and compliance with this Memorandum is hereby directed.
