- 2. The evaluation shall be done in the central schools as indicated. However, the committee is not precluded in visiting schools for validation purposes.
- 3. The PSDS shall only rate the school heads under their supervision.
- 4. The results of the review and evaluation shall be submitted to the Office of Assistant Superintendent, Mr. Roseller N. Gelig for confirmation and finally, to the Office of the Schools Division Superintendent for approval.
- 5. In order to avoid confusion/misinterpretation during the review and evaluation, a briefing of all members of the Review and Evaluation Committee is scheduled on April 11, 2017 at the Division Social Hall from 9:00 AM to 5:00 PM.
- 6. Expenses incurred due to the conduct of the briefing and the travelling and other incidental expenses, such as meals and snacks of the committee members in relation with the Review and Evaluation of RPMS of School Heads SY 2016-2017 shall be charged against the Division Funds, subject to its availability and the usual accounting and auditing rules and regulations.

7. This Memorandum shall serve as "Authority to Travel" of the participants to the scheduled briefing and during the conduct of review and evaluation.
