Furthermore, M & E Coordinators are also reminded to check in the fb account (DEPEDCEBUPROVINCE MEA) for other important reminders and preparations relative to the conduct of the DsMEA.
- 6. All schools are directed to conduct the SMEA and all districts are also directed to conduct the DsMEA conference for the fourth quarter.
