LIVE-IN ECHO TRAINING OF TRAINERS FOR IDENTIFIED GRADE 8 MAPEH TEACHERS ON ADOLESCENT HEALTH AND PRACTICAL TRAINING (ADEPT) AND ON HIV, AIDS AND STI AWARENESS AND PREVENTION

- 1. This Office hereby informs the field on the schedule of the Live-In Echo Training of Trainers for selected Grade 8 MAPEH Teachers on Adolescent Health and Practical Training (ADEPT) and on HIV, AIDS and STI Awareness and Prevention on September 18-20, 2017 at DepEd Ecotech Center, Sudlon, Lahug, Cebu City. The training will start at 8:00 in the morning of September 18, 2017.
- 2. The training aims to disseminate pertinent information and raise the level of awareness of teachers and the adolescents in school on the wide spread of HIV, AIDS and STI in our society nowadays.
- 3. This Echo Training is intended for fifty (50) selected Grade 8 teachers only, teaching Health. Each Municipality is directed to send one (1) best Grade 8 teacher teaching Health, with good oral communication skills and right attitude.
- 4. PSDSs must ensure the attendance and punctuality of their District's representatives and must see to it that their classes are well taken care of.
- 5. All participants are directed to bring laptop and an earphone. List of Resource Speakers and committee members is attached hereto.
- 6. Resource Speakers and members of the training team may check in on Saturday to attend sessions on Facilitation Skills for Trainers. Participants coming from the island may check in on Sunday afternoon of September 18, 2017.
- 7. A registration fee of **Three Thousand Six Hundred pesos (Php 3,600.00)** shall be collected from each participant to defray expenses for food and accommodation for three (3) days.

- 8. This Memorandum serves as Authority to Travel of the participants.
- 9. Registration fee, traveling and other incidental expenses incurred by the participants during their attendance to said training shall be chargeable against Local School MOOE, subject to the usual accounting rules and regulations.
- 10. Widest and immediate dissemination of this Memorandum is desired.
