1. With reference to Unnumbered Memorandum from Atty. Revsee Escobedo, Assistant Secretary, dated November 10, 2017, please be informed that due to System Maintenance of the Principals' Test Online Application System (PTOAS), there are changes in the schedule relative to the 2017 Principals' Test, which are as follows:

- 2. There are almost 1000 applicants with the same status—FOR PAYMENT. With the deadline set on November 27, 2017, the Schools Divisions are advised to devise strategies to facilitate completion of their application. It is appreciated if a call and/or a text is accorded to each applicant.
- 3. The Certificates of Ratings (CORs) of the 2016 Principals' Test Examinees are already in the Regional Office and will be forwarded to each Schools Division through one of the respective participants of each division on the QATAME capability building program at Crown Regency Residences, Guadalupe, Cebu City on November 15-17, 2017.
- 3. This division representative should forward the envelope of CORs to the Schools Division Superintendent.
- 4. The Schools Division Superintendent shall assign division personnel to distribute the COR to each examinee of the 2016 Principals' Test, which was held on April 9, 2017. This chosen staff shall maintain confidentiality of the results. Hence, he/she shall give a COR only to an examinee himself/herself or to any authorized representative.
- 5. Immediate and wide dissemination of and compliance with this Memorandum is directed.
