COMMENCEMENT OF EARLY REGISTRATION OF KINDERGARTEN TO GRADE 12

Elementary and Secondary School Heads

- 1. Pursuant to DepEd Order No. 03, s. 2018, The Department of Education (DepEd) in its mandate to ensure the delivery of accessible and quality education has established the standards and processes of enrolment in public and private schools.
- 2. This office hereby informs the field of the commencement of Early Registration for Kindergarten to Grade 12 on January 26, 2019 in all public elementary and secondary schools for SY 2019-2020, pursuant to DepEd Order No. 25, s. 2018 entitled "Implementing Guidelines on the DepEd School Calendar for SY 2018-2019".
- 3. The early registration which covers incoming Kinder, Grade I, Grade 7 and Grade 11 learners in public schools shall be conducted from January 26, 2019 to February 22, 2019. Incoming Grades 2-6, Grades 8-10 and Grade 12 are considered pre-registered, thus there is no need for these students to participate in the early registration except for transferees-in and those who are no longer in school but interested in going back to school.
- 4. The following are the objectives of the early registration:
 - a. To ensure that all five-year old children are enrolled in kindergarten;
 - b. To locate, identify and enroll out-of-school children and youth who belong to the following:
 - i. Children and youth in remote locations;
 - ii. Children and youth in difficult circumstances;

- iii. Children and youth who belong to the disadvantaged groups or who suffer discrimination;
- iv. Children and youth who dropped out but would like to go back to school.
- The School Governance Division (SGOD) is required to conduct monitoring activities, provide technical assistance, gather issues and concerns, best practices, feedback and ensure that School Heads comply with the provisions of DepEd Order No. 3. S. 2018.
- A progress report shall be submitted to the office of the Schools Division Superintendent through the SGOD Office for proper implementation of the policy. Deadline for submission of the soft and hard report is on February 28, 2018.

EARLY ENROLLMENT POLICY

- Pursuant to DepEd Order No. 03, s. 2018, the Department of Education (DepED) in its mandate to ensure the delivery of accessible and quality education has establish the standards and processes of enrollment in public and private schools.
- 2. Item V (A) of DepEd Order No. 3, s. 2018 provides the EARLY REGISTRATION of incoming Grades 1,7, and 11 learners in public schools which shall be conducted from the last Saturday of January to the last Friday, of each year. Incoming Grades 2-6, Grade 8-10 and Grade 12 are considered pre-registered.
- 3. The Schools Division Superintendents through the School Governance Operation Division (SGOD) are required to conduct monitoring activities, provide technical assistance, and gather issues, best practices, feedback and ensure that School Heads comply with the provisions of DepEd Order No. 3, s. 2018.
- 4. A progress report shall be submitted to the Office of the Regional Director for proper implementation of the 'policy. The Policy, Planning, Research and Development Division (PPRD) and Quality Assurance Division (QAD) of the Regional Office will monitor the early enrolment and compliance of the policy.
