



Greetings!

This pertains to the Assessment of the Senior High Schools under the TVL track that are being conducted in Assessment Venues (DAVs).

It has been observed that there are schools requesting for assessment using their schools as Assessment Venues which are not yet qualified as a Designated Assessment Venue (DAV). DAV is a facility appropriately equipped and designated by the Assessment Center where assessment may take place.

Section 9 of TESDA Circular No. 15 series of 2015 re Guidelines on Assessment and Certification under the Philippine TVET Competency Assessment and Certification System (PTCACS) stipulates that "Accredited Assessment Centers may establish linkages with relevant companies or enterprises for the conduct of workplace or onsite assessment as well as <u>public and private training institutions with "With Training Regulation (WTR)-registered" programs as assessment venues</u> for the purpose of assessing their graduating students/trainees. These arrangement shall however, be officially approved by the TESDA Provincial Office."

In view of the above, we have advised our Provincial Offices to strictly adhere to such provision unless the school or the training center has a WTR-registered program that would qualify them as Designated Assessment Venue.

For the safety and convenience of the Senior High School students who are interested to undergo assessment, may we recommend, if possible, for the schools to apply for accreditation as Assessment Center. Attached is a list of requirements for reference.
