- 1. This Office announces the conduct of the Division Conference of Elementary and Secondary School Master Teachers on GAD-based Integrated Curriculum for Cebuano learners to Engage for Better Understanding (IC CEBU) at DepEd Ecotech Center Pavilion on August 1 (Northern Cebu Districts) and August 2, 2019 (Southern Cebu Districts), Sudlon, Lahug, Cebu City at 8:00 a.m. to 5:00 p.m.
- 2. This conference aims to:
 - a. present updates on GAD-based (*i*C CEBU), RPMS-PPST COT and curriculum implementation by subject area, SHS, LRMDS, ALS, and Kinder/SpEd.
 - b. discuss the details of
 - Division Memorandum No. 362 (Teaching Loads for Master Teachers with GAD-Based iC Cebu Model Implementation);
 - Division Memorandum No. 406, s. 2019 (Monitoring of the GAD-based iC Cebu Lesson Exemplar (LE) Pilot Test;
 - Division Memorandum No. 387, s. 2019 (2019 Search for Outstanding Employees of DepEd Cebu Province As Amended); and
 - The Philippine Informal Reading Inventory (Phil-IRI) Manual.
 - c. share best practices on curriculum implementation programs, projects and activities (PPAs); and
 - d. design the SY 2019-2020 Master Teachers' Action Plan focused on GAD-based iC CEBU pilot implementation.
- 3. Participants to this conference are the Elementary and Secondary School Master Teachers, Education Program Supervisors (EPSVRs), Education Program Specialists II-ALS (EPSAs) and the CID and SGOD Chiefs.
- 4. A respresentative from each congressional district is expected to deliver a 10 minute presentation of best practices on curriculum implementation programs, projects and activities (PPAs).
- 5. Expenses for venue rental, lunch, snacks, conference materials and other related expenses shall be chargeable against **Division GAD Funds**, while traveling expenses of Master Teachers shall be chargeable against **local school MOOE Funds**, subject to availability and the usual accounting and auditing rules and regulations.
