CLARIFICATORY MEMORANDUM ON DEPED ORDER NO. 026, S. 2019, "GUIDELINES ON THE GRANT OF 2019 WORLD TEACHERS"

DAY INCENTIVE BENEFIT

Relative to DepEd Order No. 026, s. 2019 entitled "Guidelines on the Grant of World Teachers' Day Incentive Benefit" dated September 19, 2019, please be guided by the following clarifications:

- 1. Based on the definition of teachers under Republic Act No. 4670, the "Magna for Public School Teachers" and the Complete Staff Work (CSW) as prepared by the Bureau of Human Resources and Organization Development (BHROD), only teaching and teaching-related items (those performing supervisory and administrative functions related to teaching) are entitled to the grant of World Teachers' Day Incentive Benefit (WTDIB) at One Thousand Pesos (PhP1,000.00) per qualified teacher.
- 2. Per records, there is an estimated 908,000 positions entitled to the WTDIB while the available budget allocation is PhP800,000,000.00 only. Hence, we requested the Department of Budget and Management (DBM) for an authority to frontload available allotment for Personnel Services (PS) to cover the deficiency in the payment of the WTDIB.
- 3. Initially, the DepEd Proposal was to give incentive to all DepEd employees, but the funding allocation is not sufficient to pay all, and the DepEd Special Provision No. 12 under the FY 2019 General Appropriations Act (GAA) specifies that only teachers are entitled to the WTDIB.
- 4. In accordance with Rule I, Section I of the Implementing Rules and Regulations of the *Magna Carta for Public School Teachers*, the following positions are included in the scope of the term "teacher":
