Concerned Citizen called up this Police Station and reported this office regarding vehicular accident transpired at Sitió Banban, Brgy Pandacan, Pinamungajan, Cebu.

INVOLVED PARTIES

Victim 1/driver 1: Ramsey Sacis Alisoso (deceased), 37 years old, married, public school teacher and a resident of Rizal, Pinamungajan, Cebu, a possessor of Professional Driver's license with no. LO3 -04-002186.

Victim 2/driver 2: Roderick Trazo Benitez (deceased), 20 years old, Grade 12 student and a resident of Brgy. Rizal, Pinamungjan, Cebu, no driver's license found during the incident.

Victim 3/backrider: Jaymicito Villahermosa, 19 years old, single, Grade 12 student and a resident of Brgy. Cabiangon, Pinamungajan, Cebu.

Victim 4/backrider: Victor Hipolan, 20 years old, single, Grade 12 student and a resident of Brgy. Rizal, Plnamungajan, Cebu

Facts:

At around 5:05 pm more or less of September 25, 2019, a concern citizen reported at this police station regarding a vehicular incident that transpired at Sitio Banban, Barangay Pandacan, Pinamungajan, Cebu. Acted on the reported incident immediately thereafter, personnel of this police station under the direct supervision of ACOP FELICISIMO O ARANAS JR, responded composed of PSSg Olasiman, PSSg Navarro, PCpl Tellidua and PCpl Sayson responded and conducted initial investigation. Investigation disclosed that prior to the incident. Victim 1 was travelling onboard his (vehicle 1) Honda XRM motorcycle, color black/white, bearing plate no. 7955 SS owned by the latter, coming from their District Office situated at Tajao Elementary School, heading towards Pinamungajan National High School located at Brgy. Pandacan, Pinamungajan, Cebu, purposely to continued their started school report. However, upon reaching at the place of incident a speeding (vehicle 2), RUZI 125 motorcycle, color black without plate attached driven by victim 2 coming from Finamungajan National High School, Pandacan, Pinamungajan, Cebu, having two male back riders onboard. Vehicle 2, was tailing a tricycle on a sudden tricycle made a stop for his passenger dismount from the tricycle. Thereafter, driver 2 overtook the tricycle but the latter lost control of the steering wheel of his driven motorcycle after overtaking and now passing at the other side of the line. As a result, thereof, vehicle 2 accidentally hit on head on collision vehicle 1, tending both vehicle to fall heavily with a thud on the concreted ground. Thus, causing serious physical injuries to both drivers and inflicting less serious injuries victim 3 and victim 4 respectively. Instantly victims were rush by personnel of Municipal Disaster Risk Reduction Management (MDRRM), at Pinamungajan District Hospital for medical attention. However, upon arrival at said hospital victim 1 and victim 2 were pronounce Dead On Arrival (DOA) by the attending physician Dr. Felcius Bascon. While victim 3 was referred to Vicente Sotto Medical Center for further medical treatment. Victim 4 who sustained minor injuries was released after treatment.
