

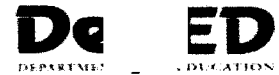

INFORMATION SYSTEM AND ENHANCED BASIC EDUCATION INFORMATION  
SYSTEM FOR SCHOOL YEAR 2019-2020**

1. The Department of Education (DepEd) has implemented the Learner Information System (LIS) and the Enhanced Basic Education Information System (EBEIS) to establish an accurate and reliable registry of learners and profile of schools, which are vital in planning and budgeting, allocation of resources, and setting of operational targets. The LIS maintains the registry of learners while the EBEIS enhances information management at all levels of governance. DepEd Order Nos. 003, and 032, s. 2018 provide the guidelines on data collection of basic education statistics, including the Muslim learners and, *asatidz* of the Arabic Language and Islamic Values Education (ALIVE) under the Madrasah Education Program.
2. Towards this end, all concerned are enjoined to provide accurate data in the sections of the Government Elementary School Profile, particularly data on the number of Muslim learners, number of ALIVE classes, data for ALIVE learners, and Personal Data on DepEd subsidized ALIVE teachers under Contract of Service (COS).
3. The teachers and school heads shall encode the aforementioned data in the LIS/EBEIS for School Year (SY) 2019-2020. The regional and division ALIVE focal persons, and planning officers are directed to monitor, supervise, and countercheck the accuracy of data being encoded in the system.
4. Starting SY 2020-2021, the allocation of Program Support Funds (PSF), honorarium, allowance, and Instructional Materials (IMS) of *asatidz* shall be based on the LIS/EBEIS data only. Hence, all levels of governance are enjoined to ensure the accuracy of data being encoded in the system.
