- In reference to DepEd Order No. 051, s. 2018 titled Guidelines on the Fiscal Year 2018 Release and Utilization of Science and Mathematics Equipment Technical-Vocational, clause 9, the Department of Education (DepEd) issues this additional provision relative to the procurement of the Learning Tools and Equipment (LTE).
- 2.. The regional directors and schools division superintendents and the school heads (for IU schools) are authorized to make adjustments in the Approved Budget for the Contract (ABC) and/or quantities of LTE (Science and Math Equipment and TVL Tools and Equipment) to be procured as originally listed on the Central Office listing to coincide with estimated cost as a result of the conduct of market survey in the respective area in accordance with relevant provisions of the Implementing Rules and Regulation of the Republic Act No. 9184.
- 3. This Order shall take effect immediately upon its approval.
