3. The status report will be consolidated for submission to the DepEd Central Office. The data is necessary in order to respond the rapid changing learning environment.
4. The early registration module in the Learners Information System (LIS) has been deployed starting on February 1, 2020, teachers and school heads can start encoding their report.
