

CREDENTIALS FOR THE 2019 CEBU DIVISION SELECTION OF ATHLETES**

1. This Office announces the conduct of the Division Checking of Athletes, Coaches, Assistant Coaches and Chaperons' credentials and ID making for the 2019 Cebu Division Selection of Athletes on February 22-23, 2020.
2. On February 22, 2019 for Cebu North and on February 23, 2020 for Cebu South, the activity will be conducted at the Division Social Hall.
3. Public Schools District Supervisor and School Heads of coaches whose credentials are with compliance are directed to report to this Office for the said schedules of activity.
4. There is no more extended schedule for the checking of the said credentials with compliance, only on February 22-23, 2020. IDs of all qualified delegates to the 2019 Cebu Division Selection of Athletes will be made once the credentials are declared final by the checkers.
5. Considering the decrease of the number of athletes whose credentials will be checked by the Division Screening of athletes committee, this office reduces the number of its members in which list is hereto attached.
6. Service Credits for teachers and Compensatory for non-teaching personnel shall be granted to those who render service on Saturday and Sunday. Submit the attendance sheets and accomplished Daily Time Record to Dr. Gerardo S. Mantos right after the activity.
7. Traveling, per diem and other incidental expenses of the coordinators and coaches shall be chargeable against Local School MOOE/SEF and other funds. The Division Credentials Committee Members traveling expenses shall be chargeable against Local School MOOE/SEF while their accommodation, meals and snacks expenses shall be chargeable against the Division Pre- Palaro funds, subject to the usual accounting and auditing rules and regulations.
8. This Memorandum serves as **Authority to Travel** of the coordinators, checkers and coaches in-charge of the credentials.
9. Immediate and wide dissemination of this Memorandum is directed.


