**SEMINAR PROGRAM FOR VIOLENCE AGAINST CHILDREN,
GENDER-BASED VIOLENCE AND OTHER RELATED VIOLENCE
INVOLVING CHILDREN DURING THE TIME OF COVID-19**

1. This Office announces the conduct of the Seminar for **Violence Against Children, Gender-Based Violence and other Related Violence involving Children During the Time of COVID-19** on **December 17-18, 2020, at Executive Hall, DepEd Ecotech Center, Sudlon, Lahug, Cebu City**. Registration will be between 7:00 – 8:00 a.m. while the Program will start at 8:00 a.m.
2. This formal face-to-face seminar will be held to achieve the following objectives:
 - a. Capacitate the participants on the various protocols and processes to ensure that learners and students will be protected against Violence Against Children (VAC) and Gender-Based Violence (GBV);
 - b. Familiarize the basic concepts, algorithms and process-flow in addressing VAC and GBV, including child safeguarding, and
 - c. Explore tips and strategies in ensuring that schools will adhere and follow the needed protocols on dealing with VAC and GBV.
3. Participants to this two-day seminar are the District Guidance Coordinators and/or other personnel chosen by the respective Public Schools District Supervisors, whose names appear on the attached list.
4. Members of the Program Management Team/Training Support Team whose names also appear on the attached list are required to be at the venue (DepEd Ecotech Center) on Day Zero (December 16, 2020) for the preparation of the venue and materials to be used for the said activity.

5. Participants from the island districts of Camotes and Bantayan are authorized to check-in on Day Zero. Only dinner will be served on Day Zero.
6. Expenses such as, accommodation, dinner on Day zero as well as all meals during the seminar, shall be charged against Division GAD Funds, subject to its availability and the usual accounting and auditing rules and regulations.
7. Participants and members of the Program Management Team/Training Support Team shall be exempted from the INSET within the covered period of the seminar.
8. The Medical section heads are also hereby directed to assign two (2) nurses, namely: Florabel Atanoza and Abigail Apple Malagar, to bring medical kit at the training venue.
9. The said seminar will be a live-in/stay-in arrangement. The first meal will be served at 7:00AM (breakfast) on Day 1 – December 17, 2020 and last meal will be served at 3:00PM (snacks) on day 3 – December 18, 2020. Expenses such as, venue, accommodation, meals, snacks and materials shall be charged against Division GAD Funds subject to its availability and the usual accounting and auditing rules and regulations. Travel and other incidental expenses of the participants shall be chargeable against Local School/SEF/MOOE Funds subject to its availability and usual accounting and auditing rules and regulations.
10. This Memorandum serves as **Authority to Travel** to participants, Program Management Team/Training Support Team and Division Personnel.
11. Participants must comply with the IATF guidelines and our DM 162, s. 2020 on Safety and Health Protocols before, during and after the seminar. They must always wear their face masks and face shields at all times.
