- 2. Required to attend this activity are all Quarter 4 Self-Learning Module (SLM) Writers of the different subject areas and grade levels. They will bring the following materials to be used during the writeshop:
 - 2.1 copy of Q4 MELCs for the assigned subject area and grade level;
 - 2.2 copy of ADM guidelines;
 - 2.3 copy of DepEd Order No. 1, s. 2021;
 - 2.4 text books and other reference materials; and
 - 2.5 laptop.
- 3. Public Schools District Supervisors (PSDSs) of the host districts are requested to facilitate the preparation of function rooms and billeting quarters of the participants in their respective districts.
- 4. The Medical Section (c/o Dr. Virgilio C. Tantuico/Dr. Asterterie A. Bernales) is requested to assign at least three (3) nurses at each venue during the entire duration of the activity.

- 5 The Assistant Schools Division Superintendent In-charge of CID, Dr. Fay C. Luarez and the CID Chief Education Supervisor, Dr. Mary Ann P. Flores are directed to monitor the preparation of SLMs at the different venues.
- 6. All personnel involved are required to follow IATF guidelines and protocols. Wearing of face masks and face shield is compulsory. Strictly, only ten (10) writers are allowed per classroom.
- 7. Transportation, per diem and other related expenses of the school-based participants shall be chargeable against **local school MOOE Funds**, while transportation, per diem and other related expenses of Division Personnel involved shall be chargeable against **Division MOOE Funds**, subject to their availability and the usual accounting and auditing rules and regulations. All personnel involved shall take charge of their own provision (meals and snacks).
