**CONDUCT OF REVALIDATION ON PRESENTATION PORTFOLIO ASSESSMENT
FOR ALS ELEMENTARY AND JUNIOR HIGH SCHOOL PROGRAM
COMPLETERS OF SY 2019-2020 AND PREVIOUS YEARS**

1. This has reference to the **Joint Memorandum No. DM-OUCI-2021-049** dated February 24, 2021 issued by the Undersecretary for Curriculum and Instruction and the Assistant Secretary for ALS entitled **Presentation Portfolio Assessment for ALS Elementary and Junior High School Program Completers of SY 2019-2020 and Previous Years.**

2. In this connection, the Division of Cebu Province Division – Alternative Learning System (ALS) will conduct a Revalidation on Presentation Portfolio Assessment for ALS Elementary and Junior High School Program Completers of SY 2019-2020 and Previous Years from March 22, 2021 to May 28, 2021.

3. Issuance of diploma and certificates shall be until the last week of June 2021 for those who are qualified and passed the minimum required points.

4. The revalidation of presentation portfolio with ALS program completers aims to:

- a. ensure that the presentation portfolios are original outputs of the completers;
- b. ensure accountability, accuracy and reliability of data; and
- c. shall be used as basis for the issuance of an Elementary Diploma or a Junior High School Level Certificate of Program Completion.

5. The modality for the conduct of the said activity shall depend on the quarantine protocol level set by the Inter-Agency Task Force (IATF).

6. Education Program Specialist II in ALS (EPSAs) are instructed to conduct the above-mentioned activity in their respective areas of assignment.

7. Travelling, board and lodging, and other incidental expenses incurred during the conduct of revalidation shall be chargeable against the **CY 2020 ALS Program Support Funds (PSF) and/or Division Funds**, subject to its availability and the usual accounting and auditing rules and regulations.
