

- As most divisions and regions have already completed Part I (self-learning modules) of the Learning Delivery Modalities (LDM) courses, regional LDM program management teams are instructed to facilitate the issuance of certificates of participation, as mentioned in the evaluation guides issued last year through

   and
  - a. A participant gets a Certificate of Participation when he or she gets an overall descriptive rating of at least Satisfactory or a final rating equivalent to or higher than 2.500 for Part I/Preimplementation (Modules 1-6).
  - b. If a participant gets a rating below Satisfactory, the coach/leader assigned to the LAC may conduct a validation in coordination with the LAC hader/other coaches. Validation may be done by holang at the outputs or intercipating the participant and his or her colleagues, as may be deemed necessary.
  - c. Once calidation and agreement hace been made by RO. CO, and external partner coaches, NEAP-R facilitates the issuance of the Certificate of Participation signed by the Regional Director.
- 2.
