GUIDELINES ON TEACHING AND NON TEACHING PERSONNEL FOLLOWING COVID-19 VACCINATION

1. COVID-19 vaccination is one of the major strategies to complement the existing measures and practices to mitigate the spread and reduce morbidity and mortality due to coronavirus infection.
2. DepEd personnel who wish to be vaccinated are advised to register for their free vaccination through their respective local government units (LGUs).
3. In line with this and in reference to the Regional Memorandum No.0511, s. 2021, all teaching and non-teaching personnel scheduled for vaccination shall be allowed to be out of the office/school on **Official Time** during their vaccination day. A copy of their vaccination card must be submitted to their respective school heads or section heads upon reporting to office for validation.
4. Furthermore, appropriate work accommodation will be given in the event that the personnel has experienced mild to severe side effects after the vaccination. The concerned worker is entitled to a **Work From Home (WFH) arrangement** depending on the severity of the side effects. However, before they can avail, they must inform their respective School Heads and coordinate with their School Health and Nutrition Personnel for proper assessment, monitoring and issuance of a medical certificate.
5. Immediate dissemination of this Memorandum is desired.
