 - d. Practice physical distancing (at least 1 meter apart) at all times. Prolonged and close physical interaction increases the risk of transmission. Limit interaction to decrease the risk of transmission.
 - e. Limit face to face activities and travel as much as possible unless absolutely necessary.
 - f. Know the facts of COVID-19 and help stop the spread of rumors and the disease. Everyone is advised to refrain from spreading unverified reports and /or false news to avoid undue stress and worry due to misinformation.
 - g. Support the FDA approved COVID-19 vaccines. The vaccine for COVID-19 is an integral part of disease prevention and should be complemented by the observance of these Minimum Public Health Standards.
