Ms. Alicaway shall now take rank 99 in the Final RQA with overall rating of 75.47 taking over the place of Johanie Mae Otadoy (75.44). Ms. Otadoy shall now be rank 100, and the succeeding teacher-applicants downward shall be one (1) rank lower. Refer to HRMPSB Resolution No. 03, s.2021 regarding the clarification raised by Ms. Beverly Alicaway for non-inclusion in the Final RQA.

ELEMENTARY FOR THE SCHOOL YEAR 2021-2022 DATED 07 OCTOBER 2021**

Whereas, on October 8, 2021 Ms. Beverly S. Alicaway sent a letter-complaint to the Schools Division Superintendent channeled to Dr. Joel B. Umbay, Public Schools District Supervisor of San Fernando 2 complaining about her **non-inclusion or omission** in the Registry of Qualified Applicants for the Teacher 1 position-Elementary which as posted in the Division' website on October 7, 2021 through Division Memorandum No. 416 dated 30 September 2021;

Whereas, as raised by Ms. Alicaway (complainant), her name was in the Tentative Registry of Qualified Applicants for Elementary Level based on the posted Memorandum of the Division Office which was released on August 31, 2021; she ranked 127th in the tentative ranklist having obtained the overall average rating of 75.47;

Whereas, on October 8, 2021 the schools division superintendent issued an unnumbered memorandum directing/ordering the Division Selection Committee Members-Elementary Level to immediately convene in order to find solutions on the letter-complaint raised by the above-mentioned teacher-applicant;

Whereas on October 11, 2021 the members of the Division Selection Committee Elementary Level convened at the Office of the HRMPSB Chairman, and agreed the following:

1.The District Sub-selection Committee needs to immediately write a letter of apology to the teacher-applicant, Ms. Beverly S. Alicaway due to such omission or failure of the committee members to exercise proper and due diligence (being extra-careful) in preventing such occurrence; the Division Selection Committee needs also to write a letter of apology to the teacher-applicant due to its lack of foresight in reviewing the scores or ratings (of the said applicant) before its final printing and posting in the Division's website;

2.It is also agreed that the score of Ms. Beverly S. Alicaway shall be immediately corrected from 63.47 to 75.47; and that she should be given the corresponding rank number 99 in the over-all ranking in the Registry of Qualified Applicants for Elementary Level.

Wherefore, based on the foregoing arguments, the chairman and members of the Division's HRMPSB/Division Selection Committee (DSC), unanimously **AGREED** and **RESOLVED**, that an addendum/corrigendum to Division Memorandum No. 416 entitled: "Registry of Qualified Applicants for Teaching Positions in the Elementary, Junior High School and Senior High School Levels of DepEd Division of Cebu Province for the School Year 2021-2022" dated 30 September 2021 shall be immediately posted/released.

Resolved, as it is hereby resolved further, that Ms.Beverly S. Alicaway's rank shall be number 99 taking over the place of Johanie Mae Otadoy (75.44); Ms. Otadoy's rank shall now be number 100, and the succeeding teacher-applicants downwards will move or slide down by one (1) number lower (in that order) due to the inserted score of 75.47 from teacher-applicant, Ms. Beverly Alicaway of Ciriaco V. Paradela IS, Tinubdan, San Fernando, Cebu.

Resolved, finally that a corrigendum or addendum shall be prepared immediately by the Division's HR Section/Unit in response to the letter-complaint of Ms. Beverly Alicaway; a **stern warning** is also hereby given to the District Selection Committee members that in the exercise of its duties and responsibilities, **due diligence, proper foresight and good faith** must be exerted at all the times, and a repetition of a similar incident will be dealt with accordingly.


