1. This Office announces the Tentative Ranklist of Non-Teaching and Related-Teaching Applicants for Transfer of Station of Deped Cebu Province Division for SY 2021-2022.
2. The Ranklist is categorized as follows:

3. The Ranklist shall be posted and open for clarifications from concerned applicants from **November 5-20, 2021**. After the necessary corrections and it will be for implementation.
4. Clarification and correction of points shall be coursed through the Human Resource Merit and Promotion Selection Board (HRMPSB) Sub-Committee in writing with the corresponding documents to support such claim. Clarifications made after the given period shall no longer be accommodated for the HRMPSB Secretariat to finalize the ranklist. **Mode of communication shall be through the email address/FB messenger of the District Supervisor as Chairman of the HRMPSB Sub-Committee and other platform limiting face-to-face interaction.** After verifying the request/claim, the PSDS shall communicate and transmit online the necessary corrections with the supporting documents to the Office of the Assistant Schools Division Superintendent/HRMPSB Chairman, Dr. Anelito A. Bongcawil.
5. The HRMPSB Sub-Selection Committee shall submit the final ranklist for consolidation only after all the necessary adjustments have been made. It is expected that the committee has thoroughly reviewed all entries in the ranklist prior to submission.
6. The Division Selection Committee shall no longer accommodate changes after the final ranklist is submitted for consolidation.
